**MEMORANDUM (MOTION FOR EMAIL COMMUNICATIONS)**

Plaintiff hereby files this Memorandum in support of his Motion for Email Communications.

The situation here is exceedingly simple: The Plaintiff desires that communications between the parties (in their roles as legal representatives for the purposes of the instant *Tuvell v. Marshall* litigation) be available via email. The Defendant refuses to do so. He has blocked Plaintiff's email communications (as he admits in his Motion to Dismiss, page 6, ¶9); several emails sent from Plaintiff to Defendant have gone unacknowledged.
