Subject: My information to you in regards to the letter sent by Chief Justice John Roberts in the Justice Kavanaugh nomination case

condition that I get my own Business Visa ,I immediately went to the US consulate in India and told them that my visa is for legal purpose and I have to file my legal case in United States Federal DC Court.

Now I am under constant watch and if I contact any lawyer these criminals contact that lawyer even before me and they are working very hard to prevent me from being able to file my case -petition in the United States Federal Court in Washington DC .

OK .But the most important issue is about the criminal senators .McConnell and other republican and Democratic Senators are deeply involved in this criminal cover up .I am asking the Supreme Court to promulgate orders to get these senators investigated thoroughly and if they are found involved in any kind of criminal activity and criminal cover up they have to be thoroughly prosecuted in the court of law .So these senators wanted to make a deal with me.

Right from outset I was opposed to Kavanaugh nomination and they wanted to make a deal with me to let them go if they do not vote for Justice Kavanaugh .But I refused to listen to any of them .Dear sir ,now is the moment .You have taken an oath for the office which you serve in the name of your country .Please do not let this country dive into a repository for criminals.
