5 **ORDER**

6 THIS MATTER came on for hearing before this Court on Plaintiff's Motion for  
7 Fees and Costs on Contempt Proceedings and Plaintiff's Motion for Fees and Costs on  
8 Third Contempt Proceeding. On June 29, 2012, the Court granted Plaintiff's Motion for  
9 Fees and Costs on Contempt Proceedings. Dkt. 155. On July 30, 2012, the Court granted  
10 Plaintiff's Motion for Fees and Costs on Third Contempt Proceeding. Dkt. 186.

11 This Court has previously ordered that amounts held in the Court Registry and  
12 amounts bonded in connection with the DeCourseys' previous attempts to appeal would  
13 be held as supersedeas for the DeCourseys' current appeal. Dkt. 374. Now, therefore,

14 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Plaintiff Lane  
15 Powell PC is awarded judgment against Defendants Mark and Carol DeCoursey, in the  
16 principal amount of the \$23,379.00 (\$12,992.53 + 10,456.47). Because these amounts are  
17 liquidated, Lane Powell is awarded an additional \$1,990.52 (\$1,159.59 + 830.93) for  
18 interest accrued on the principal amounts through March 28, 2012 (the date noted for  
19 presentation of this judgment) for a total amount including principal and interest of  
20 \$25,439.52. Post-judgment interest on the entire sum shall accrue at the rate of twelve  
21 percent (12%) per annum from the date of entry hereof.

22 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this judgment  
23 is stayed pending final resolution of the Judgment Debtor's appeal.

24 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that, in the event  
25 Lane Powell prevails on appeal, upon issuance of the mandate, the Clerk of Court and  
26 CBIC are directed to immediately release amounts sufficient to satisfy this judgment plus

1 post-judgment interest on the funds held in the Court Registry or as a bond to Lane Powell  
2 PC, in care of McNaul Ebel Nawrot & Helgren PLLC.

3 IT IS SO ORDERED.
