Yes, Mark, thank you for getting back to me so promptly! I am pursuing an appeal at Middlesex Superior Court (Woburn), case №1781CV02701 (docket attached). I also have a website, and the case is also documented there: http://judicialmisconduct.us /CaseStudies/TUVELLvMARSHALL.

I need a transcript of the oral argument. I spoke to two clerks, and they gave me different information. I also read the rules of court, but perhaps I don't understand them well enough.

One clerk told me audio recordings were available at For The Record, http://us.court.fm. I visited that website, and got access to the audio I need (attached). I downloaded it (as an MP3), and transcribed it (without objection from the Defendant), which I've already filed with the court. Both the audio MP3 and the transcript are available on my website. I thought that was all I needed to do.

But the other clerk I spoke to (yesterday) said I needed to contact your office, and order a CD, to be sent to the court (not to me). I wasn't clear what was supposed to happen then. In particular, it wasn't clear how I was supposed to arrange for a transcription (they're expensive, and unnecessary in this case, since I've already made a perfectly good transcription myself).
