

On September 27, 2018, Brett Kavanaugh sat before the Senate Judiciary Committee and gave testimony in response to allegations of sexualually assaulting a classmate while he was in high school. During this hearing, I believe that Kavanaugh acted in a manner completely unfitting for a judge, and certainly for a nominee to the Supreme Court. Of particular concern is the politically partisan comments he made, such as the following quote:

This whole two-week effort has been a calculated and orchestrated political hit, fueled with apparent pent-up anger about President Trump and the 2016 election. Fear that has been unfairly stoked about my judicial record. Revenge on behalf of the Clintons. and millions of dollars in money from outside left-wing opposition groups.

This, and many other comments were made for the nation to see, and demonstrate a man who is politically charged, not one who will render decisions based solely on facts and evidence, regardless of political party.

Such behavior certainly brings into question the validity of any decision he may rule upon as potentially politically motivated. The public must be able to trust that the court system will rule without the influence of political parties. For Mr. Kavanaugh, that is not the case, and for that reason I feel that it is my civic duty to file this complaint against him.
