This matter was tried by a jury of twelve from October 21, 2008 to October 29, 2008, the Honorable Michael J. Fox presiding. Defendant and Third-Party Plaintiffs Mark and Carol DeCoursey ("DeCourseys") appeared through their attorneys of record Brent L. Nourse and Andrew J. Gabel. Third-party Defendants Paul H. Stickney, Paul H. Stickney Real Estate Services, Inc., and Windermere Real Estate/SCA, Inc. appeared through their attorneys of record Matt Davis and L'Nayim Shuman-Austin. The parties presented evidence and testimony to the jury. On October 30, 2008, the jury returned a verdict in favor of the DeCourseys on their claim for Breach of Fiduciary Duty in the amount of \$515,900. The jury also returned a verdict in favor of the DeCourseys on their claim for violation of the Washington Consumer Protection Act in the amount of \$6,300 for a total amount of damages of \$522,200. A copy of the jury's special verdict is attached as Exhibit A.

On February 5, 2009, the Honorable Michael J. Fox heard Defendant and Third-Party Plaintiffs Mark and Carol DeCoursey's Motion for Attorneys' Fees and Costs. Third-party Defendants Paul H. Stickney, Paul H. Stickney Real Estate Services, Inc., and Windermere Real Estate/SCA, Inc. appeared at the hearing through their attorney of record Matt Davis. The Honorable Michael J. Fox granted DeCourseys' Motion for Attorneys' Fees and Costs in the amount of \$463,427.00 in Attorneys' Fees and \$45,000.00 in Costs. A copy of the Court's February 6, 2009 Order is attached hereto as Exhibit B.

Consistent with the jury's verdict in this action, the Court enters final judgment in this matter as follows:

- The DeCourseys are awarded a total amount of \$1,030,427.00 against Paul Stickney, Paul H. Stickney Real Estate Services, Inc. and Windermere Real Estate/SCA, Inc. jointly and severally.
- 2. The total amount of the judgment, including interest accrued to date and costs and attorneys' fees, shall bear interest at the statutory rate as provided under RCW
