ORDER

THIS MATTER came on for hearing before this Court on Plaintiff's Motion for Fees and Costs on Contempt Proceedings and Plaintiff's Motion for Fees and Costs on Third Contempt Proceeding. On June 29, 2012, the Court granted Plaintiff's Motion for Fees and Costs on Contempt Proceedings. Dkt. 155. On July 30, 2012, the Court granted Plaintiff's Motion for Fees and Costs on Third Contempt Proceeding. Dkt. 186.

This Court has previously ordered that amounts held in the Court Registry and amounts bonded in connection with the DeCourseys' previous attempts to appeal would be held as supersedeas for the DeCourseys' current appeal. Dkt. 374. Now, therefore,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Plaintiff Lane Powell PC is awarded judgment against Defendants Mark and Carol DeCoursey, in the principal amount of the \$23,379.00 (\$12,992.53 + 10,456.47). Because these amounts are liquidated, Lane Powell is awarded an additional \$1,990.52 (\$1,159.59 + 830.93) for interest accrued on the principal amounts through March 28, 2012 (the date noted for presentation of this judgment) for a total amount including principal and interest of \$25,439.52. Post-judgment interest on the entire sum shall accrue at the rate of twelve percent (12%) per annum from the date of entry hereof.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this judgment is stayed pending final resolution of the Judgment Debtor's appeal.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that, in the event

Lane Powell prevails on appeal, upon issuance of the mandate, the Clerk of Court and

CBIC are directed to immediately release amounts sufficient to satisfy this judgment plus
