After all, you do proactively advertise your email addresses, in official publications (under your control/imprimatur). And the emails I send to you are successfully delivered (insofar as my email client and Internet provider assure me). Surely you're not going to pretend you're not receiving them, are you? So, why don't you answer them?

As you know, what you're doing (refusing to respond to me by email [or even U.S. Mail, to date]) is unethical. ABA Model Rules of Professional Conduct 1.0(n), 1.4 (applicable here, because in essence I am a "client" of you U.S. Lawyers).

And please don't pretend you're worried about the security of email. If you were, you'd institute appropriate measures (such as supporting secure/encrypted email, which I use, but I can't use it with you because you don't).
