Hello, OGE —

I do understand, according to your "Where to Report Misconduct" webpage (<https://www.oge.gov/web/oge.nsf/Mission> and <https://www.oge.gov/web/oge.nsf/Responsibilities/CE915BAFE0BF5DA185257EA60065573E?opendocument>, copy attached hereto), that complaints of ethical/legal misconduct are not "handled" by your office. Nevertheless, I am hereby "informing" you of complaints I have filed, as an **FYI: I thought you should be aware of these** because they're so important to our American democracy. If there is anything you can do (legally/ethically of course) to help resolve these complaints, I (and the whole U.S.A.) would be extremely grateful.

My complaints are all **very fully documented** on my website (which I keep up-to-date), at <https://judicialmisconduct.us/CaseStudies/WETvIBM>, so I limit myself to just a summary here. Namely, you should know I have submitted complaints of **CRIMINAL behavior** (hence *a fortiori* ethical misbehavior) against the following entities:

- **Multiple Federal Judges.** See the two Smoking Guns (one by District Judge, one by Appellate Judges) on my webpage (mentioned above). [Yes, I do realize federal judges are not directly within your jurisdiction, but see the remainder of this list, all in the executive branch.]
- **FBI, PIN, OPR.** They have all refused to respond to my complaints of criminal behavior, which constitutes criminal league/conspiracy with the above-mentioned federal judges.
- **EOUSA.** They have responded to me, in a manner (lying/stonewalling /gaslighting) that constitutes affirmative criminal behavior, in league/conspiracy with the above-mentioned federal judges.
- **U.S. Attorney (D.Mass.) Andrew Lelling.** He has responded to me, in a manner (lying/stonewalling/gaslighting) that constitutes affirmative criminal behavior, in league/conspiracy with the above-mentioned federal judges.
- **DOJ IG Michael Horowitz (plus other IG employees under him).** They are responsible for refusing to uphold/enforce integrity/ethics with respect to the above named executive branch DOJ entities, which constitutes affirmative criminal behavior, in league/conspiracy with the above-

mentioned federal judges.

My complaints are currently being processed ("pre-investigated") by **CIGIE**, about whom I have no complaints at this time: hopefully they will conduct themselves honorably/honestly.
